GENERAL GUIDELINES FOR THE CANTON FLEA MARKET

LOCATION, DATES, AND HOURS: The Canton Flea Market Arts and Crafts Show is held on the second Thursday in May and October each year on the grounds of the Madison County Courthouse in Canton, Mississippi, between the hours of 7:00 A.M. and 4:00 P.M.

I. ENTRY TO SHOW

- A. Exhibitors are permitted by invitation only.
- B. Applications are received and reviewed by the Committee.
- C. All exhibited crafts MUST be handmade by the exhibitor.
- D. The fee is \$150.00 for each 10' X 12' space.

II. PROCEDURE OF SHOW

- A. Exhibitors are required to be present in order to sell their own merchandise.
- B. All exhibitors are required to be set up by 7:00 A.M. and remain until 4:00 P.M.
- C. The Flea Market Committee will juror all exhibits during show time.
- D. Sales tax is collected at each Show. You may price your items to include the tax.

III. ACCEPTANCE OF SHOW

- A. Each exhibitor will be allowed to bring only two categories of crafts.
- B. It is not permissible to share your booth with another exhibitor or to sell any other person's merchandise out of your booth.
- C. All exhibitors must exhibit only arts and crafts entered on the application. Additional items must be approved by the Committee.
- D. You will automatically be issued an invitation for each Market once accepted , unless otherwise notified.
- E. All exhibitors must make their own provision for shade or rain.

- F. If you do not respond to the invitation for our Market, whether accepting or declining, you will not receive an invitation to the following Show.
- G. If you decline two consecutive Markets, you will not be issued an invitation to the following Market.
- H. Exhibitors are not allowed to transfer their invitation.
- I. Refunds for cancellations are made provided cancellation is made by the specified deadline.
- J. Exhibitors may exhibit at only one location in Canton.

IV. CRAFT GUIDELINES:

- A. Crafts must be handcrafted by the exhibitor and in finished form.
- B. ABSOLUTELY NO IMPORTS OR WHOLESALE MERCHANDISE
MAY BE SOLD AT THE COURTHOUSE SQUARE AREA.

PLEASE NOTE: We have a very large Show. These guidelines have been developed in the best interest of the exhibitors and the buying public. These are for your protection and ours to maintain a quality Show.
